

RULES – Challenger Christmas Competition 2025

Article 1: Purpose

The company **TRIGANO VDL**, a simplified joint-stock company with a capital of €7,000,000, whose registered office is located at **100 rue Petit – 75019 Paris**, registered with the Paris Trade and Companies Register under number **458 502 838**, operating from its main establishment at **1 avenue de Rochebonne – 07302 TOURNON-SUR-RHÔNE**, is organising a free competition with no purchase necessary from **28 November 2025 at 9:00 a.m. to 23 December 2025 at 12:00 p.m.** on the Instagram and Facebook accounts of **Challenger** (hereinafter “the Organising Company”).

Participation is validated when:

- the Instagram account **@challenger.motorhome** is followed,
- the competition post is liked,
- **2 friends** are mentioned in a comment,
- and the post is shared in a story to increase the chances of winning.

Article 2: Access to the competition

The competition is free, with no obligation to purchase, and open to any natural person **aged 18 or over** residing in a European country.

Only one entry per person is permitted.

Participation implies full acceptance of these rules.

Article 3: Dates and duration

The competition will take place from **28/11/2025 at 09:00 to 23/12/2025 at 12:00**.

The Organising Company reserves the right to modify or postpone these dates if necessary.

Article 4: Selection of the winners and publication of results

A **random draw** will be carried out on **23 December 2025** from among participants who have complied with the participation requirements.

The winners will be contacted exclusively via **private message** on Instagram or Facebook on **24 December 2025**.

Article 5: Prizes

The prizes offered are:

- **2 nomadic barbecues Accessoires VDL**
- **2 Challenger Welcome Packs**

A total of **4 winners** will be selected.

The prizes cannot be transferred, exchanged, refunded, or converted into financial compensation.

Article 6: Delivery of the prizes

If no reply is received within this period, the prize will be allocated to another participant in accordance with Article 4.

Article 7: Free participation

No reimbursement for any costs (Internet connection, equipment, etc.) will be made.

Article 8: Use of personal data

The data collected are used exclusively for:

- contacting the winners,
- sending the prizes.
